#### Hello fellow aviators!

Here are the notes from the finance and admin side of the club this month:

- The storage area of the club house now has a new combination lock on it. If you need access to anything in this space, please contact one of the club officers to open it for you.
- 21 club members have now paid their dues for 2024. With the 4 club officers, that brings out total for the renewed 2024 memberships to 25. That leaves 35 members still to renew.
- Please can junior members still fill out the renewal form, so that I can confirm the desire to renew and make sure we have the correct contact information.
- I will have 2024 membership badges ready for the February meeting.
- As this completes my first year as treasurer, I thought I'd do a summary of the income and expenses for the club for 2023. I categorized all the transactions and grouped them up. Here is the summary:

#### Here are some interesting highlights:

- Donations for food at club meetings and events are significantly lower than the cost of the catering. Some of this is due to the two times the club provided pizza at Abby's (\$440 in total), but we still spent more on the BBQs than we received in donations for them (by about 30%).
- Money raised from donated planes and accessories accounts for nearly 25% of the club income. When you are considering offering a donation for something the club has been given, please consider how valuable this is for the club.
- Overall, the club made a loss of nearly \$500. If the number of donation items is lower in 2024 or if the club membership declines, we may end up with a large loss in 2024.
- At the January meeting, I will have my spreadsheet with the details of all these numbers, so if anyone has any questions, I'd be happy to dig in further.
- Last year I set up PayPal and Venmo for people to pay dues, donations and other things. As we brought in more than \$600 through PayPal payments, I have had to convert the accounts to business accounts for tax purposes. This means you can no longer do "Friends & Family" payments to the club, and we get charged a fee for every incoming transaction. I would ask that, moving forwards, if you wish to pay for something using PayPal or Venmo you add 3% to the amount you send to cover the fee (i.e. dues would be \$72.10 for an adult).
