Hello friends

Here are the notes from the finance and admin side of the club this month:

- 38 club members have now paid their dues for 2024. With the 4 club officers, that brings out total for the renewed 2024 memberships to 42. That leaves 18 members still to renew.

- Please can junior members still fill out the renewal form, so that I can confirm the desire to renew and make sure we have the correct contact information.
- Please note the wording in Section 5 of our By Laws (<http://www.eugenerc.org/wp/constitution/>):

- 3: Members still delinquent by the February meeting will be advised by mail or email that dues must be paid, along with a \$10.00 late fee, by the March meeting. If this does not take place by the March meeting, they will be dropped from the club membership and will not be permitted to use any designated club flying area.
- 4: Dropped members that rejoin the club after the March meeting shall pay the initiation fee of (\$5.00 or \$25.00) but not the lifetime "Field Improvement Fee". They shall pay the appropriate annual dues (no dues for members 18 or under) for that year. If a dropped member rejoins after the dropped year they will be treated as a returning member.
- 5: Returning members pay only the (\$5 or \$25) initiation fee but not the lifetime "Field Improvement Fee". They shall also pay the yearly dues as provided by Article III of the By-Laws.
- The following admin tasks for 2024 have been completed:
 - AMA Club Charter has been renewed.
 - Oregon DOJ Charities Filing has been made.
 - Oregon Business Registration has been renewed.
 - IRS "e-Postcard" has been filed.
 - PO Box is set up to auto-renew and should renew around 2/16.
- Reminder: if you wish to pay anything to the club using PayPal or Venmo, please confirm the amount with me as this will incur additional charges for us now.
